A1224C	Jeffries (MS) -- Relates to requiring voter approval for the abolition or modification of term limits for certain elected offices
A1313	Brodsky (MS) -- Establishes a closed-circuit television system and surveillance personal privacy act
A1833	Dinowitz (MS) -- Relates to penalties for the illegal shipment of cigarettes
A2323	Jeffries (MS) -- Prohibits more than one increase in the price of motor fuel in any twenty-four hour period

A4054	Gantt (MS) -- Relates to the comprehensive school bus driver safety training program
A4234	Giglio -- Authorizes the county of Cattaraugus to impose an additional 25 cents per \$100 mortgage recording tax
A4300	Canestrari (MS) -- Provides that actions by the attorney general for unlawful practice of law shall include both civil and criminal actions
A4632A	Thiele -- Relates to granting peace officer status to uniformed members of the fire marshall's office in the village of Southampton
A4633A	Thiele -- Designates employees of the village court of the village of Westhampton Beach serving as uniformed court officers as peace officers
A4758A	Morelle (MS) -- Relates to standard fire insurance policies
A4768A	Jordan -- Authorizes the county of Washington to impose hotel or motel taxes
A4790	Weinstein -- Extends until 2014 the provisions of chapter 455 of the laws of 1997 conferring certain powers on New York city marshals
A5311A	Sayward -- Designates the village of Lake George seasonal constables as peace officers
A5617	Errigo (MS) -- Requires certain information given to parent and consent be obtained without coercion for temporary removal of child with consent

A7545B	Millman (MS) -- Specifies what constitutes appropriate shelter for dogs restrained outdoors and maximum and minimum temperature range for exposure
A7670	Gottfried (MS) -- Relates to motions to vacate judgment against victims of sex trafficking for certain prostitution offenses
A7868	O'Mara -- Designates animal control officers employed by the county of Schuyler as peace officers

A7949A	Silver (MS) -- Authorizes superintendent of insurance to approve a demonstration program where an eligible insurer issues group health insurance policies to eligible associations
A8049	Zebrowski -- Authorizes the attorney general to bring an action for violation of the prohibitions concerning unlawful selling practices and specifies damages awardable
A8103A	Pretlow -- Provides for accelerated payments to the city school district of the city of Mount Vernon
A8105	Jeffries (MS) -- Provides that supervision fees for parolees shall be collected at a central location and shall not be collected by parole officers
A8115	Butler -- Amends chapter 489 of the laws of 2004, relating to the mortgage recording tax in the county of Fulton, to extend the effectiveness of such chapter

S1788	STEWART-COUSINS -- Authorizes Gate of Heaven cemetery to transfer land to the Cemetery Floral Company
S2760	MONSERRATE -- Establishes the reverse mortgage fairness act of 2009
S3357	ONORATO -- Requires employers to give written notice of the rate of pay and the regular pay day upon hiring, and get written acknowledgment thereof from each employee
S3784	THOMPSON -- Extends the special powers of the New York state environmental facilities corporation
S4768	BRESLIN -- Enacts the fraternal benefit society risk based capital act of 2009; establishing risk-based capital requirements applicable to fraternal benefit societies; repealer
