

Re: Annual Report of the Committee on Codes - 2009

Dear Speaker Silver:

It is with great pleasure that on behalf of the Committee on Codes, I submit to you the committee's 2009 Annual Report highlighting its activities during the first half of the 2009 – 2010 Legislative Session.

Among the committee's many notable accomplishments were the historic reforms to the Rockefeller Drug Laws by restoring judicial discretion to our sentencing laws and increasing protection of children by enacting "Nixzmary's Law to punish those that mistreat our children the most cruelly.

The Committee also helped enact the strongest DWI laws in the country by creating a new felony for persons driving while intoxicated with a child and mandating the installation of an ignition interlock device by every person convicted of a DWI offense. We expanded the law's protection of domestic violence victims by creating a new law that would permit certain low-level criminal convictions involving acts of domestic violence to be made available to law enforcement. By mandating consecutive sentencing of certain violent criminals, we helped close a loophole in the Penal Law that permitted those convicted of the most heinous of our crimes, A-1 violent felons, to escape the full measure of justice. We also helped enact laws to protect consumers from abuses in the debt collection and mortgage foreclosure processes.

There were numerous other legislative accomplishments of which the Committee and the Assembly can be justly proud that are set forth in this report.

The Committee extends its appreciation to you for your support. In addition, I would like to thank the committee members and staff for their hard work during the 2009 Legislative Session.

I. COMMITTEE JURISDICTION

The New York State Assembly Standing Committee on Codes considers issues and legislation regarding the State's criminal and civil justice system. Most of the legislation considered by the members of the Codes Committee amends the Criminal Procedure Law, the Penal Law, the Civil Practice Law and Rules as well as selected articles of the Executive Law.

In addition, the Committee's "dual reference authority, pursuant to Rule IV § 6 (i) of the Rules of the Assembly of the State of New York, places within its jurisdiction legislation initiated in any of the other Assembly standing committees which imposes or changes any fine, term of imprisonment, forfeiture of rights or property, or other penal sanction as well as legislation related to the procedure by which such fine, term of imprisonment, forfeiture or other penal sanction is imposed or changed."

II. SUMMARY OF LEGISLATION MOVED BY THE COMMITTEE ON CODES AND ENACTED IN 2009¹

A. Protecting Our Children

1. Harsher Punishment for Killers of Children Also known as "Nixzmary's Law", this new law requires, when it is alleged that a person has killed a child in a torturous manner, that the prosecution, in order to seek a life-without-parole sentence, not have to prove that the defendant relished or evidenced a sense of pleasure in inflicting extreme physical pain. By eliminating this element of proof in the case of an adult alleged to have killed a child, it assures that a sentence of life imprisonment without possibility of parole may be sought in such circumstances. (A.5080/ S. 6091, Chapter 482)

B. Punishing A-I Felony Offenders

1. Providing For Mandatory Concurrent Sentences This law mandates that a court impose consecutive sentences for defendants convicted of A-I felony offenses such as those relating to terror, murder, kidnapping and arson and certain child sexual assault crimes while still under sentence for committing a prior crime. It also requires that such offenders serve at least half of this new sentence before being considered eligible to apply for medical parole. (A.40005/S.660005; Chapter 495)

C. Protecting Against Sex Offenders

1. Making Sex Offender Registration Material More Accessible This law enables New York State residents to receive changes or updates in subdirectory of level 2 and 3 sex offenders by e-mail in a specific locality at no charge. By amending subdivision 1 of section 168-q of the correction law, as amended by chapter 10 of the laws of 2003, it provides that any resident of the state may register with the Division of Criminal Justice Services to receive e-mail notification when a registration has been entered or updated in the subdirectory of level two and three sex offenders in a geographic area specified by the resident. E-mail updates will be provided free of charge for specific counties or zip codes. (Corrections, A.1242 – B/ S.1362-C, Chapter 478)

D. Fighting Domestic Violence

- 1. Protecting Victims of Domestic Violence Building on a law enacted in 2008, this law further protects victims of domestic violence, particularly in cases where there is a shared ownership interest in property, and also preserves protections previously in place for persons acting under a reasonable belief. (A.2006/ S.4306, Chapter 45)
- 2. Recognizing the Special Needs of Domestic Violence Victims This law requires that lawyers who specialize in the representation of children receive training in domestic violence. It also mandates that a court state on the record whether domestic violence and child abuse factored into its award of custody or visitation. The measure also would require that certain low-level criminal convictions involving acts of domestic violence, which might otherwise be sealed, be made available to law enforcement. (Judiciary, A.9017/S.5031-A, Chapter 476)

E. <u>Protecting the Exercise of Constitutional Rights</u>

1. Protecting Volunteers Who Work in Reproductive Health Service Facilities
This law makes it a new class E felony ("Aggravated interference with health care services in the second degree") to cause physical injury to someone who is obtaining, providing or assisting someone to obtain or provide reproductive health services. It also makes it a new class C felony ("Aggravated interference with health care services in the first degree") to cause serious physical injury to someone who is obtaining, providing, or assisting someone to obtain or provide reproductive health services. Repeat offenders of offenses involving interfering with reproductive health care services are also properly punished. Most importantly, for the first time, it makes it a crime to cause physical injury and serious physical injury to volunteers who are assisting others to obtain or to provide reproductive health care services rather than just the actual provider of those services. (A.8924/ S.6112, Chapter 493)

F. Protecting the Public from Construction Accidents

1. Amending Crane Inspector Law This law makes a technical amendment to chapter 463 of the laws of 2007 which established the offense of impairing the integrity of a government licensing examination and amended the general business law in relation to crane inspectors. (A.7014/ S.3564, Chapter 64)

G. Housing and Mortgage Reform

- 1. Crackdown on Abusive Landlords This new law toughens civil penalties against landlords who violate the Division of Housing and Community Renewal rent-regulated housing codes. The measure better protects tenants from being forced out of their apartments by landlord harassment. (Housing, A.2002/S.2493; Chapter 480)
- **2. Protecting Homeowners from Mortgage Fraud** This law expands the availability of pre-settlement conferences to all homeowners, provides greater notice requirements to co-op owners in the lien foreclosure process and amends the Penal Law with respect to the residential mortgage fraud crimes created last year to provider greater protections for legitimate homeowners and mortgagors. (Judiciary, A.40007/S.66007; Chapter 507)

H. Insurance Reform

- 1. Managed Care Reform This law enhances consumer and medical provider protections by limiting the basis for denying claims for health care services and strengthens the rights of providers to challenge an insurance plan's over payment recovery efforts for services previously authorized. The measure also would outline consumer grievance procedures and otherwise improve access to treatments for rare diseases. (Insurance, A.8402 / S.5472-A; Chapter 237)
- 2. Regulating the Life Settlement Industry For the first time, New York State will require that life settlement brokers and life settlement providers be licensed. To further protect consumers, it creates specific crimes for acts committed against consumers who are defrauded by businesses and individuals that engage in wrongful or deceptive practices in this industry. It also creates a private right of action for aggrieved consumers. (Insurance, A.40009/ S.66009; Chapter 499)

I. <u>Promoting Driver Safety</u>

- **1. Bicycle Safety** This law requires bicycles used one-half hour after sunset to one-half hour before sunrise, to be equipped with a red or amber rear reflector to increase visibility in low light conditions. (Transportation, A.669 / S.2250; Chapter 16)
- **2.** Leaving the Scene of a Boating Accident This law increases penalties for leaving the scene of a boating accident. (Transportation, A.2262-A / S.1610-A; Chapter 297)
- **3. Small Watercraft Safety** This law requires passengers in boating vessels of less than 20 feet during the months of November through May 1 to wear a personal floating device at all times thereby reducing the number of drownings that have occurred in recent years as a result of small boat accidents in cold water. (Transportation, A.6784 / S.3024; Chapter 115)

- **4. Texting While Driving Banned** This law provides that no person shall operate a motor vehicle while using any portable electronic device while such vehicle is in motion, with exceptions its is aimed at texting but affects other devices, as well. It also provides that such prohibited conduct shall be a traffic infraction punishable by a fine. (Transportation, A.8568-B/ S.3619-A; Chapter 403)
- **5. Booster Seat Use** This law raises the age of passengers who are required to be restrained in an appropriate child restraint system from six to seven years old. (Transportation, A.8612-A/S.3623-A; Chapter 405)
- 6. Driving While Intoxicated with Child This law (known as "Leandra's Law") creates a new felony based on any person operating a motor vehicle while intoxicated (a BAC of .08 or "common law" DWI), or ability impaired by drugs or the combined influence of alcohol and drugs with a child passenger fifteen years of age or less. The law also requires every court to sentence anyone convicted of a DWI to install an ignition interlock device as part of a conditional discharge, probation, or parole. (Transportation, A.40008/S.66008, Chapter 496)

J. Making Civil Justice System Fairer

1. Creating a More Level Playing Field in the Tort System This law would treat municipal employees the same as private sector employees by prohibiting them from seeking recovery against a public employer for damages otherwise covered by insurance and will protect parties to the settlement of tort claims from certain unwarranted liens, reimbursements and subrogation claims. (A.40002/ S.66002, Chapter 494)

III. SUMMARY OF SIGNIFICANT LEGISLATION MOVED BY THE COMMITTEE ON CODES IN 2009 THAT ONLY THE ASSEMBLY PASSED

A. Protecting Children, the Vulnerable, the Elderly and Victims of Hate

- 1. **Missing Vulnerable Adults Clearinghouse** This bill creates the missing vulnerable adults clearinghouse and provides for plan and implementation programs to ensure the most effective use of federal, state, and local resources in the investigation of missing vulnerable adults. (Aging, A.5220/ S.2056-A)
- **2. Vacate Judgments Against Victims** This bill relates to motions to vacate judgment against victims of sex trafficking for certain prostitution offenses. (A.7670/S.4429)
- 3. Safety Act This bill enacts the "SAFETY Act"; authorizes the office of children and family services to establish policies and procedures affording all children in OCFS facilities an environment free of harassment and discrimination based on actual or perceived race, national origin, ethnic group, religion, disability, sexual orientation, gender or sex; requires reporting harassment and discrimination. (Children and Families, A.3645)

B. Protecting the Public Against Sex Offenders

- **1. Registration Violations** This bill requires the Division of Criminal Justice Services to provide additional information when a sex offender is in violation of registration requirements. (Corrections, A. 2108/ S.2923)
- 2. Failure to Register This bill provides that an offender who fails to register or verify as a sex offender shall have the period of time of such failure to register or verify added to the duration of registration. (Corrections, A.2132/ S.4743)
- **3. Criminal Trespass** This bill establishes that a person is guilty of criminal trespass in the second degree when he or she, being required to maintain registration as a sex offender, enters or remains in a school knowing that the victim of his or her offense attends or formerly attended such school. (A. 2257/ S.1606)

C. Protecting Victims of Domestic Violence

1. Time Off for Domestic Violence Victims This bill requires employers to authorize a period of time off of up to 90 days within one year to victims of domestic violence. The measure aims to provide victims with a reasonable amount of time to address the myriad of issues caused by the violence without fear of losing their job or benefits. (Labor, A.438-B/ S.5610)

- **2. Inquiry of Possession of Firearm** This bill requires the judge in a criminal proceeding or in a family court proceeding, upon issuance of an order of protection to inquire as to the possession of a firearm by the defendant or respondent. (A.4320-A/S.1647-A)
- **3. Enforcement of Orders of Protection** This bill exempts parties liable for failure to obey or enforce certain child protective, domestic relations, or domestic violence orders of protection or temporary orders of protection from limited liability provisions pertaining to non-economic loss and providing for limitation of joint liability. (A.5516/S.4452)
- **4. Extending Orders of Protection** This bill provides the period in which an order of protection is in effect would be tolled and thereby extended for the time that a person is incarcerated on a misdemeanor charge. (A.5705)
- **5. Expanding Definition of Serious Offense** This bill expands the definition of "serious offense" for purposes of being licensed to carry a firearm to exclude those convicted of certain crimes associated with domestic violence from obtaining a gun. (A.7575-A)
- 6. Domestic Violence Victim Housing and Employment Discrimination Prohibits discriminatory practices against individuals in relation to housing and in employment matters because they have been victims of domestic violence. (Governmental Operations, A.9020 / S.5999)

D. Fighting Gun Violence

- 1. Firearm License Renewal This bill would put a limit on the life of a gun license and require the re-licensing and recertification of firearms permits after five years. (A.801-A/S.1598-A)
- 2. Firearm Dealer Practices This bill would require the creation and imposition of restrictive commercial practices and stringent recordkeeping and reporting to prevent gun sales to criminals. It also includes reporting of gun sales, liability insurance, and employee training for gunsmiths to prevent the sale of guns through "straw purchases". (A.1093/ S.1715)
- **3. Firearm Safety Course** This bill would encourage responsible gun ownership by establishing a standard firearms safety course requirement for individuals who are applying for a gun license. (A.3076-B/ S.5489)
- **4. Revoking Firearm Licenses** This bill would authorize a court to revoke the firearms license and seize the weapons of certain individuals who have been adjudicated as incapacitated or ordered to treatment or commitment to a mental facility. (A.7733/ S.5466)
- **5. Pawnbroker Firearm Regulations** This bill would require that current laws and regulations that govern gun dealers will apply to pawnshops that deal in firearms. (A.7574/ S.5465)

- **6. Children's Weapon Accident Protection Act** This bill would help protect children from accidental shootings by establishing new crimes involving the negligent storage of a weapon. The legislation also would require gun retailers to alert consumers about the new safe weapons storage requirements. Under the measure, individuals convicted of failing to store safely a firearm where a serious injury results could face prison sentences of up to seven years. (A.5844/ S.3098)
- **7. Child Proofing Firearms** This bill would ban the sale of firearms that are not equipped with child proof features. Under the bill, pistols and revolvers could not be sold in the state unless they were designed in a way to prevent their operation by a child. (A.1326/ S.5228)
- **8. Sniper Rifle Ban** This bill would ban the civilian possession, sale and use of military style .50-caliber or larger weapons, and creates a program to recall those that are currently legally owned. (A.3211-A/S.4752)
- **9. Disguised Guns** This bill would make it a felony for anyone to design or transform a firearm to resemble a toy gun by altering or concealing the original color or surface of the gun with the purpose of selling such weapon. (A.5078/ S.725)
- **10. Criminal Weapon Possession** This bill would make possessing armor piercing, frangible or devastator ammunition a felony. (A.2881/ S.2379)
- **11. Expended Projectiles and Shell Casings** This bill would require law enforcement officers to submit expended projectiles and shell casings and guns to the state police pistol and revolver ballistic identification electronic databank. (A.2882-A)
- **12. Assault Weapon Ban** This bill would expand the legal definition of assault weapons to strengthen the state's law that prohibits possessing these deadly, military-style guns. (A.6157)
- **13. Microstamping** This bill would ensure that when a gun is fired, information identifying the make, model and serial number of the gun is stamped onto the cartridge as numbers and letters. (A.6468/ S.6005)

E. Police and Community Relations Package

- 1. **Discharge of Weapon** This bill requires police officers who have discharged their weapon in the course of their employment to be tested for the presence of drugs and/or alcohol within three hours of such discharge; establishes procedures to protect the integrity of such process; applies to officers employed in cities with a population of 1,000,000 or more. (Labor, A.1477/ S.2592)
- **2. Police Misconduct** This bill grants the attorney general jurisdiction to investigate and prosecute police misconduct upon the request of the governor or the district attorney of the county wherein such misconduct was committed. (Governmental Operations, A.1486/ S.2059)

- **3. Monitoring of No-Knock and Other Warrants** This bill makes various provisions to the criminal procedure law in relation to the execution of a warrant of arrest; authorizes the commissioner of the division of criminal justice services to establish a system to record and monitor the issuance and execution of search warrants; and authorizes the chief administrator of the court system to establish educational programs for judicial personnel on the law of searches, arrests and seizures. (A.1508-A/S. 2594-A)
- **4. Racial Profiling** This bill prohibits police officers from using racial and ethnic profiling and requires that a procedure be established for the taking and review of complaints against police officers for racial and ethnic profiling. It also allows an action for injunctive relief and/or damages to be brought against a law enforcement agency, any agent of a law enforcement agency and the supervisor of an agent. (A.1676/ A.65)
- **5. Search Warrant Denials** This bill provides that an applicant for a search warrant must disclose all prior denials of the same or similar application, as well as any prior failure to issue such a warrant by a different judge, if known to the applicant. (A.5457)
- **6. Police/Peace Officer Registries** This bill consolidates and streamlines the police officer and peace officer registries, and upgrades and clarifies minimum training requirements for peace officers, repealer. (A.7957-A/S.6102-A)

F. Aiding Crime Victims

- 1. Crime Victims Ombudsman This bill establishes a crime victim's ombudsman and provides for such ombudsman's functions, powers and duties. (Governmental Operations, A.521)
- **2. Bias-Related Violence** This bill establishes a civil remedy for victims of bias-related violence or intimidation for deprivation of a civil liberty, property damage, injury or death motivated by race, religion, national origin, sex, disability, age or sexual orientation to recover actual damages, injunctive relief or other appropriate remedy; includes attorneys fees. (Governmental Operations, A.529/ S.5923)
- **3. Crime Victims Compensation** This bill expands eligibility for those who receive awards under crime victims' compensation to include a domestic partner; defines domestic partner; further provides for out-of-pocket loss to include the cost of counseling for surviving family members of homicide victims. (Governmental Operations, A.4089/ S.1422-A)
- **4. Lengthening Orders of Protection** This bill provides that a final order of protection that is issued by a court (for example, in a domestic violence case) shall extend not from the date of conviction (i.e., guilty plea or verdict), as is currently provided under these statutes, but from the date of sentencing. A temporary order of protection may be ordered or continued for the period between conviction and sentencing. The effect of the bill will be to lengthen, generally by a few months, the

period during which a final order of protection will be in place in the case (A.8807/S.6070)

G. Expanding the Use of DNA

1. DNA Recovery and Opportunities to Prove Innocence Expanded This bill establishes the minimum period of time that forensic samples should be retained by investigating authorities; creates the state commission for the integrity of the criminal justice system, as an independent agency, and provides for such commission's powers and duties; relates to special fictitious name indictments; relates to requests for certain DNA test comparisons; relates to forensic DNA testing; relates to claims for unjust conviction and imprisonment; relates to DNA testing, data collection and record keeping; and relates to DNA testing in felony cases. (A.6528/ S.4668)

H. Protecting Animals

- 1. Care of Abused Animal This bill authorizes the district attorney to bring animal abuse charges to petition for the posting of security for the care of the abused animal on behalf of the impounding organization; authorizes all such petitions to be filed at or after the arraignment on animal abuse charges. (Agriculture, A.3765/S.5479)
- 2. Animal Cruelty This bill requires that individuals convicted of certain animal cruelty and animal fighting offenses reimburse the organizations caring for such animals. (Agriculture, A.3168/ S.3155)
- **3. Animal Population Control** This bill creates an animal population control fund to fund the animal population control program which reduces the population of unwanted stray dogs and cats; encourages neutering of animals. (Agriculture, A.6158-A/ S.4278)

I. <u>Protecting Consumers</u>

1. **Mortgage Brokers** This bill prohibits home improvement contractors from also acting on behalf of mortgage brokers; prohibits a mortgage broker from paying a home improvement contractor directly unless they perform their own inspection of the completed work. (Banks, A.170/S.5102)

J. <u>Debt Collection Protection</u>

1. Consumers Package This bill: protects consumers from abusive debt collection practices, improving New York's Debt Collection Practices Law; prohibits improper and abusive debt collection practices and procedures; and governs how debt collectors may communicate with debtors. The bill would largely align New York Law with the federal Fair Debt Collection Practices Act. (Consumers, A.8840-B/ S.6036)

- **2. Debtor's Bill of Rights** This bill requires that debt collection firms provide consumers a written notice detailing the manner in which the collection agency is permitted to recover a debt and the rights of debtors under state law. (Consumers, A.271-A /S.3797)
- 3. Licensing Debt Collection Agencies This bill mandates that third party debt collection firms operating in New York be licensed by the Department of State. The legislation would require that firms submit a summary of the methods used to confirm the accuracy of the debts it seeks to recover. (Consumers, A.3926-C)
- **4. Recourse Against Unscrupulous Debt Collectors** This bill provides consumers with a private right of legal action to seek damages from a collection agency when there is evidence of a violation of the state's debt collection law. (Judiciary, A.3532-A/ S.2458)
- **5. Debt Collectors** This bill prohibits debt collectors from collecting or attempting to collect a debt owed by a deceased debtor that is known by such debt collector to be deceased. (Consumers, A. 7889-A)

K. Privacy Protection

- 1. Closed-Circuit Television System and Surveillance Personal Privacy Act This bill provides for privacy protections in relation to the operation and use of closed-circuit television (CCTV) systems by state authorities, the state highway system, and municipalities. It would prohibit monitoring by such systems of persons or private property except in certain circumstances such as emergencies. The bill also would prohibit the collection of personal identifier information by CCTV, and restrict the recording of CCTV data. Under the bill, the CCTV system data would be used solely for transportation planning, traffic management, and traveler information purposes. (Corporations, A.1313/S.4329)
- **2. Toll Record Confidentiality** This bill establishes reasonable, uniform provisions for maintaining the confidentiality of electronic toll and electronic fare records, including "Metrocard" and "E-Z Pass" records, while at the same time authorizing disclosure to accommodate the needs of law enforcement. (Governmental Operations, A.4985/S.5077)

L. Health Safety

1. Discontinue Usage of Certain Pesticides This bill would phase-out the use of pesticides on state property and require the state to adopt a pest control policy that substantially relies on non-chemical pest control methods. (Environmental Conservation, A.5848/S.4043)

- 2. **Bisphenol-A Products** This bill prohibits the sale of any toy, child care product or beverage container containing bisphenol-A in products intended for children under three years of age. (Environmental Conservation, A.6919-B/S.3296)
- **3. Decabromodiphenyl Prohibition** This bill would ban the use of the chemical flame retardant Decabromodiphenyl (DecaBDE) in electronics, textiles and mattresses. (Environmental Conservation, A.7573)
- **4. Food Calorie Disclosure** This bill requires certain restaurants and food service establishments to post the caloric value of food items on their menu. (Health, A. 9027)
- **5. Trans Fat Food Ban** This bill prohibits certain restaurants and food establishments from serving foods containing artificial trans fat. Under the bill, food items that contain less than 0.5 grams per serving of trans fat will not be banned nor would food products that contain naturally occurring trans fat. (Health, A.6359/S.5937)

M. Promoting Driver Safety

- 1. Seat Belt Use in Back Seats This bill prohibits any person from riding in the rear seat of a motor vehicle unless the individual is properly restrained by a seat belt. (Transportation, A.225-A/S.1169-B)
- 2. Children to Ride in Back Seats This bill prohibits the operation of a motor vehicle with any passengers under the age of seven seated in the front seat. Under the bill, there are several exceptions, including for medical reasons, a lack of rear seats, and when a child safety seat or booster seat can not be properly installed in the rear seats. (Transportation, A.4181/S.2238)

N. Protecting Workers

- 1. **Domestic Workers** This bill provides rights and benefits to domestic workers who are otherwise excluded from such basic protections as a weekly day of rest, overtime pay, and the ability to bargain collectively. The legislation also extends disability coverage and provides protections under the anti-discrimination law while granting the Department of Labor greater ability to enforce wage and hour standards for these workers. (Labor, A.1470)
- 2. Farm Workers Fair Labor Practices Act This bill enacts the Farm Workers Fair Labor Practices Act, which would grant collective bargaining rights, workers compensation and unemployment insurance benefits, as well as 24 hours of rest and over time to farm workers. (Labor, A.1867/S.2247)
- **3. Equal Pay** This bill makes unequal pay on the basis of sex for work of comparable worth an unlawful discriminatory practice under the state Human Rights Law. (Governmental Operations, A.2351/S.2968)

4. Fair Pay Act This bill establishes the New York State Fair Pay Act which seeks to ensure that pay differentiation is not based on a person's sex or national origin. The measure also would require that private and public employees are compensated for the work they perform based on their job titles. (Labor, A.3911/S.955)

O. Lobbying Reform

1. Ethics and Lobbying Reform This bill strengthens oversight and enforcement of New York's ethics and lobbying laws and provides the public with improved accountability and transparency by requiring greater financial disclosure by public officials and lobbyists. It would establish the Commission on Lobbying Ethics and Compliance, thereby restoring an independent commission on lobbying. It also creates the Joint Legislative Commission on Ethics and Standards and an independent Legislative Office of Ethics Investigations and an Executive Ethics Compliance Commission to replace the current Commission on Public Integrity.

The legislation would require increased financial disclosure for all public officials by ending the practice of redacting categories of value on legislative ethics disclosure forms; adding an additional category of value to better identify higher-level financial interests; and requiring better descriptions of outside employment, including consultant businesses and business associations and appearances before state agencies.

In addition, the legislation also would increase disclosure by requiring lobbyists and clients of lobbyists to disclose business relationships they have with state public officials. (Governmental Operations, A.9032/S.6064)

V. <u>CODES COMMITTEE PARTICIPATION IN HEARINGS AND ROUNDTABLES IN 2009</u>

A. <u>Impact of the State Budget on Access to Justice Hearing</u>

The Judiciary, Codes, Corrections and Governmental Operations Committees held a hearing on February 24th to assess whether the need for legal services for low income New Yorkers is being met and to examine the impact of the economic crisis and recent state budget cuts on such legal services. Providing quality legal services to all regardless of economic and social status is the underpinning of any fair and just society. This hearing provided the participating Assembly standing committees with an opportunity to assess the ongoing need of such services funded by the state to those requiring civil or criminal legal services who cannot afford them, and as well to those who are incarcerated. Special attention was given to the current economic downturn, the state budget and the concomitant increased demand for legal services by those who have felt its harshest effects.

The committee members heard from representatives of the Interest on Lawyer's Account (IOLA), the private bar, civil, criminal and prisoner legal service providers and their clients and examined the challenges facing these legal service providers from both a caseload and funding perspective. Not surprisingly, testimony demonstrated that the recent economic downturn has increased the demand for no-cost legal services. Testimony also focused on the need for steady and consistent legal services funding in order to ensure a continuity of services from year to year. Additionally, the committees heard testimony about steps that should be taken to make New York's assigned counsel system more efficient and effective. Following the hearing, the Assembly restored over \$7 million for civil legal services and \$2.3 million in funding for Prisoners Legal Services in the SFY 2009-10 State Budget which had been omitted from the Executive's budget.

B. <u>Jury Pool Diversity Hearing</u>

In response to claims that jury pools in certain counties were not properly representative of the citizens of those counties resulting in certain groups being under-represented on juries, the Assembly Codes and Judiciary Committees held an important hearing in New York City on April 30, receiving testimony from bar association groups, the Office of Court Administration, a Cornell University Law School Professor, and others. As a result of the information gleaned from the hearing, the Judiciary Committee reported and the Assembly passed A.2374 (Lancman, Jeffries et al.), which authorizes the Commissioner of Jurors of each county to collect demographical information concerning the ethnicity, race, gender, and age, of Jurors with an ultimate aim of insuring that those utilizing our civil and criminal justice systems indeed are able to appear before a "jury of their peers".

C. <u>Street Gangs in New York Roundtable</u>

On Wednesday, April 22, 2008, a roundtable discussion entitled, "Street Gangs in New York," co-sponsored with the Committee on Children and Families took place. Participants encouraged the legislature to support ongoing, community based approaches to this problem. Speakers stressed that a strictly punitive, criminal justice response to street gangs would only be counter productive. Experts called for the state to provide opportunities for young gang members to pursue gainful employment and legitimate enterprise.

VI. DRUG LAW REFORM

The cost to incarcerate a lower-level, non-violent drug offender is approximately \$45,000 a year. The cost to place such a person in a residential drug rehabilitation facility -- including the cost of drug treatment services -- is less: approximately \$15,000 per year. Moreover, study after study has shown that substance abuse treatment can be much more effective in reducing recidivism than incarceration alone.

Legislation approved and signed into law this year (Chapter 56, Part AAA) finally brought about significant reform of New York's inflexible Rockefeller Drug Laws. Our Committee and the State Assembly have for years advanced legislation reforming these mandatory sentencing laws and their failed, one-size-fits-all approach. This year, we succeeded in restoring needed judicial discretion and authorizing substance abuse treatment programming for many lower-level offenders as a potential alternative to a lengthy prison sentence.

This new law does not lower maximum sentences. Judges may still impose prison terms of the same length they did before. But the new law gives judges the discretion to divert certain persons charged with non-violent, lower-level drug and marijuana offenses to a treatment regimen supervised by a treatment provider or the local probation department and the court. The treatment provider or probation department will monitor the person's progress and give reports to the courts. Infractions may result in escalating sanctions, discharge from the program and traditional prosecution and sentencing. For those who successfully complete the treatment regimen, criminal charges may be reduced or dismissed.

The law also authorizes courts to conditionally seal records of certain drug, marijuana and other lower-level, non-violent crimes after the defendant has successfully completed a judicial diversion program, prosecutor-sponsored DTAP program, or a similar treatment program. A new arrest for any crime will unseal these records pending disposition of the new charge; the records will be permanently unsealed if the new charge results in a conviction for any crime.

Changes are made with respect to those sentenced (and not diverted) in drug cases as well. While maximum sentences are not changed, the courts are afforded additional discretion when making certain sentencing determinations. For example, a first-time felony offender convicted of a class B drug felony may be sentenced to one year or less in the county jail or five years probation supervision. Previously, a state prison sentence of at least one year was required. The minimum, mandatory prison term for a second felony offender (with a prior, non-violent felony) is reduced from two years to one and a half years.

The new law makes changes to prison programming as well. Judges are given expanded authority to sentence certain non-violent, drug-involved persons to the Department of Correctional Services ("DOCS") Willard drug treatment prison in Seneca County, New York. The state Office of Alcoholism and Substance Abuse Services ("OASAS") is directed to monitor alcohol and substance abuse programming within

DOCS facilities, issue guidelines for the operation of such programs, and prepare annual reports concerning their findings.

Also, the law authorizes DOCS and the courts to enroll eligible inmates in the DOCS Shock Incarceration boot-camp style program when such inmates are within three years of parole or conditional release eligibility. Previously, only those who entered DOCS with less than three years remaining until parole of conditional release eligibility could participate in the program. Further, the maximum age for those entering the DOCS Shock Incarceration program is increased from forty to fifty years of age.

A limited class of inmates serving an indeterminate prison sentence for a class B drug offense under prior law is authorized to seek discretionary resentencing by the sentencing court. Among such offenders ineligible to seek resentencing are persons convicted of a violent felony with ten years prior to the application date and persons who, at any time, were adjudicated a second violent or persistent violent offender.

Finally, the new law established two new crimes with enhanced sentencing ranges. First, a new class B felony is created for an adult over age twenty-one who sells a controlled substance to a child under age seventeen. ("Criminal Sale of a Controlled Substance to a Child," Penal Law §220.48.) Second, a new class A-I drug crime is created. Under this new law, a person convicted for his or her role in a "controlled substance organization" involving more than \$75,000 in proceeds faces a life sentence with a minimum term of imprisonment (before parole eligibility) of between fifteen and twenty five years.

VII. DWI REFORM

So-called "Leandra's Law" passed in extraordinary session this year makes New York's driving while intoxicated laws the most stringent in the nation. It makes it a class E felony to operate a motor vehicle while intoxicated or ability impaired by drugs or the combined influence of alcohol and drugs with a child passenger fifteen years of age or less. It creates new felony level offenses in the Penal Law to include the act of driving while intoxicated with a child passenger fifteen years of age or less as an element of the crimes of Vehicular Assault in the First Degree (D Felony) and Aggravated Vehicular Assault (C Felony) where there is serious physical injury to the child, as well as the crimes of Vehicular Manslaughter in the First Degree (C Felony) and Aggravated Vehicular Homicide (B Felony) where there is the death of a child.

Significantly, it mandates that every person sentenced to any misdemeanor or felony driving while intoxicated offense to install an Ignition Interlock device as a condition of probation, conditional discharge or parole.

The legislation was in response to several tragic car crashes resulting in the deaths of child passengers while in the care of intoxicated drivers, including the death of 11 year old Leandra Rosado who was killed while riding with six other children in a station wagon driven by a drunk adult. In addition to the stricter penalties, a person charged with the new E felony will be limited in their ability to plea bargain and may face further review by Child Protective Services where the arresting officer finds the circumstances warrant reporting to such agency.
