**As I reported to you last weekend, we finally passed a State budget on Sunday, April 9th - 9 days past due.** The legislature is now on recess for the Passover and Easter Holidays and will return on Monday, April 24th.

While we did pass a budget, there could be more changes based on the Federal government's budget later this year. There is a plan in place in this budget that if the federal government cuts \$850 million or more of funding to New York State, the Governor's division of budget will develop a plan for spending cuts that will automatically go into effect in 90 days, unless the Assembly and Senate provide an alternative plan.

With this prospect on the horizon, I am holding a town hall meeting with New York City Comptroller, Scott Stringer called **"Trump and the Budget" on Wednesday, May 10th at John Jay High School.**

Once I am back up in Albany next week to continue the legislative session, I expect that both the Assembly and Senate will begin to take on some substantive issues that were not in the budget.

Earlier this session, the Assembly passed a number of bills including:

Having passed the Assembly it is now the Senate's turn to act on these critical pieces of legislation that would have a profound impact on women's health issues and Immigrant families across New York State. If these issues are important to you, I urge you to reach out to your Senator to make sure that they are a supporter of these bills.

Another bill that has tremendous support in the Assembly, is the [New York Health Plan](#), which would provide universal health coverage for New Yorkers. I anticipate that this bill will pass the Assembly soon and then will be on to the Senate as well.

Additionally, I plan to get to work on many of the electoral reform bills that I introduced earlier this session, including the [Young Voter Act](#), which would lower the legal voting age in New York to 17.
