Toll Relief: Goethals, Bayonne and Outerbridge Crossings

A toll relief plan I negotiated last year gives E-ZPass holders a reduced toll on their third trip over New Jersey spans in a 30-day period. Once the third trip is taken, the first two trips paid at a peak rate of \$10.25 are rolled back to \$5.25. To sign up for the three-trip plan call the Port Authority at 1-800-333-8655 or visit www. panynj.gov. You can also go to the New York E-ZPass Customer Service Center at 1150 South Avenue, Staten Island, NY 10314. Those enrolled in the 10-trip plan will be automatically absorbed into the three-trip plan.

Verrazano-Narrows Bridge

Staten Island residents receive an \$8.64 discount (\$6.36 round trip versus the \$15.00 cash rate) on the bridge. If a resident takes more than two round trips in a calendar month, the discount will be \$9.00 (\$6.00 round trip versus the \$15.00 toll rate). Vehicles must be registered to a valid resident address in Staten Island. Please note that vehicles used for commercial purposes are not eligible for residency plans. MTA MetroCard Discount

For customers who are 65 years of age or older or have a qualifying disability. The base subway or local bus fare is \$2.50. Reduced fare is half the base fare, \$1.25 or less with Reduced-Fare MetroCard discounts. Access-A-Ride (AAR)

Access-A-Ride provides transportation for people with disabilities who are unable to use public bus or subway service for some or all of their trips. It offers shared ride, door-to-door paratransit service. MTA New York City Transit administers AAR; private carriers under contract to NYC Transit provide service. EDUCATION AND TUITION AID

State scholarships, grants and awards

NYHELPs state loan program offers students (if they have a cosigner), parents, and legal guardians or sponsors a loan equaling the cost of their attendance minus all other federal and state financial aid. Visit www.hesc.com/nyhelps.

The Aid for Part-Time Study (APTS) program provides grant assistance for eligible part-time students enrolled in approved undergraduate studies. Awards provide up to \$2,000 per year for part-time undergraduate study at participating institutions in New York State. Visit www.hesc.com/content.nsf/SFC/Aid for PartTime Study.

College Tuition Tax Credit

If you, your spouse, or a dependent attended an institution of



higher education as an undergraduate and paid qualified tuition expenses you may be eligible for the college tuition tax credit.

Veterans Tuition Awards

These awards apply to full-time study and part-time study for eligible veterans enrolled in either an undergraduate degree, graduate degree or diploma and certificate programs at degree-granting institutions or noncredit vocational training programs of at least 320 clock hours specifically approved by the New York State Education Department.

The Iraq and Afghanistan Service Grant is for undergraduate students who are not eligible for a Pell Grant, but whose parent or guardian was a member of the U.S. Armed Forces and died as a result of service performed in Iraq or Afghanistan after September 11, 2001.

TAXES AND EXEMPTIONS

STAR School Property Tax Reduction Program

All property owners receiving the Basic STAR exemption for school property taxes must follow new registration requirements in order to continue receiving the Basic STAR property tax exemption. The registration ends December 31, 2013. If you do not register you will not continue to receive this exemption. Senior citizens who receive Enhanced STAR are not impacted by the new registration requirements. However, senior citizens must continue to file each year as they have in the past. IMPORTANT INFORMATION

Veterans Property Tax Exemption Program

Qualified veterans living in a private house, condominium, or cooperative apartment who served during specific periods of conflict in the armed forces during one of the following: Persian Gulf Conflict (beginning Aug. 2, 1990), Vietnam War (Feb. 28, 1961 to May 7, 1975), Korean War (June 27, 1950 to Jan. 31, 1955), World War II (Dec. 7, 1941 to Dec. 31, 1946)



are eligible for a property tax exemption. Other owners who are eligible: wife or husband of a qualified veteran, surviving spouse of a qualified veteran (who has not remarried), and Gold Star parents. Call 518-457-2036 or visit http://www.tax.ny.gov.

Tax Preparation

Earn \$57,000 or less last year? You may be able to file your taxes for free or at low cost by using the city's tax preparation services. Find out if you are able to claim tax credits such as the Earned Income Tax Credit and the NYC Child Care Tax Credit. HOME ENERGY ASSISTANCE PROGRAM

TELEPHONE LIFELINE

RENT RELIEF

The Senior Citizen Rent Increase Exemption program (SCRIE) and the Disability Rent Increase Exemption (DRIE) program give assistance to eligible residents age 62 and older and the disabled. Call NYC Department of Finance at 311 or visit www.nyc.gov/finance.

HELP AT HOME

Expanded In-home Services for the Elderly Program (EISEP) helps residents age 60 and older who want to live at home but need help with activities, such as dressing, bathing, shopping and cooking. Call the NYC Department for the Aging at 212-442-1000 or visit www.nyc.gov.

PRESCRIPTION DRUGS



BigAppleRx is the City of New York's official prescription discount card developed to help NYC consumers save on their medication costs. It provides discounts averaging 47%; 15% average on brand-name drugs and 53% on generic drugs. STATEN ISLAND VETERANS DISCOUNT PROGRAM

Assemblyman Cusick partnered with the Staten Island Chamber of Commerce to initiate a discount program for veterans of the United States military who live in Staten Island. Bring your discharge papers (DD-214) to receive the Staten Island VETS card.

ACCESS NYC

ACCESS NYC is a free service that helps you find out if you may qualify for over 30 City, State and Federal benefit programs such as Medicaid, Supplemental Nutrition Assistance Program (SNAP) benefits or help with utility bills.
