Karma for Cara Foundation is a nonprofit organization founded by 21-year-old Cara Becker and her family while she was undergoing treatment for leukemia at the Johns Hopkins Kimmel Cancer Center. Cara and her two brothers began volunteering at a young age as part of their family's commitment to community service. She and her family saw a tremendous need to help support other patients and their families who were also challenged by cancer. Tragically, Cara passed away four months after her diagnosis, yet her wish to help others through K4C lives on with the support of an ever-growing circle of family and friends. The Youth Microgrant Program promotes and supports youth volunteerism throughout the United States. Examples of fundable projects include – but are not limited to – turning a vacant lot into a community garden, rebuilding a school playground or helping senior citizens get their homes ready for winter.

Kids 18 and under can apply for a community service project they feel passionate about.

Grants are awarded in amounts between \$250 and \$1,000.

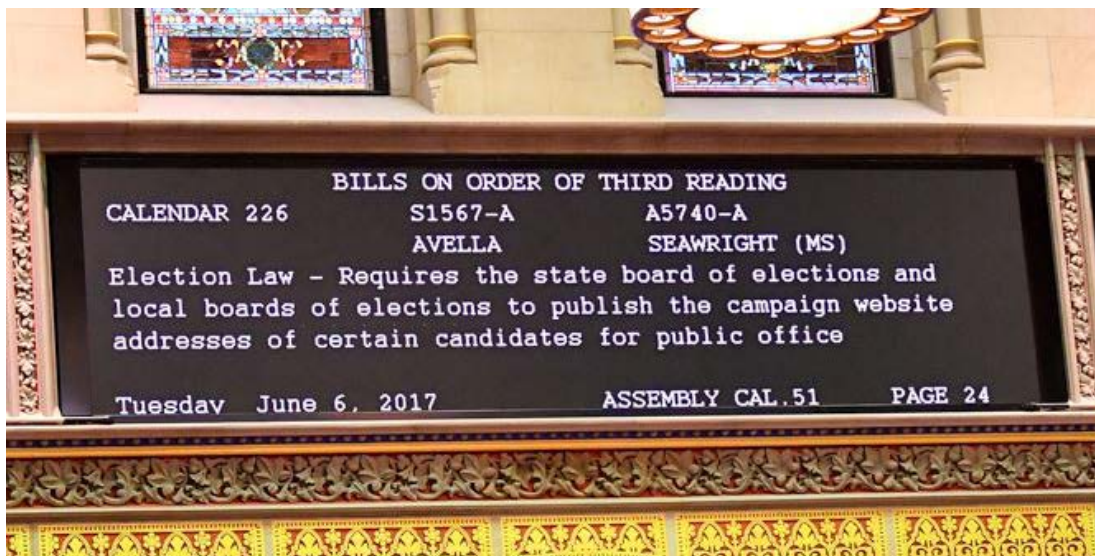

Seawright's Election Reform Bill Promoting Transparency Passes Both Houses



On Tuesday, June 6, 2017 Assembly Member Rebecca A. Seawright obtained passage of Assembly bill 5740-A, which would provide the public with increased access to information on political candidates in a centralized location. The bill passed with bipartisan support in the Assembly by a vote of 102-1. This bill, introduced by Senator Tony Avella, also passed in the Senate and will be delivered to the Governor at an agreed upon date.

“This bill provides voters with additional resources to research and evaluate candidates for political office. By including a link on the New York State Board of Elections website, we are increasing access to information about candidates that wish to represent them. This is a win-win for the voter,” said **Assembly Member Rebecca A. Seawright**.

If signed into law, this legislation would make campaign websites easily accessible for state candidates running for Governor, Lieutenant Governor, Attorney General, State Comptroller, Senate and Assembly. Candidates who do not provide their campaign website when they file to run for public office will be listed on the webpage as not having declared a website.

“I will continue to introduce and support bills that demonstrate my commitment to increasing transparency and easy access of information to the residents of the State of New York,” said **Seawright**.

Seawright Joins Assembly Member Deborah Glick to Fight for New Speed Cameras to Keep Children Safe

Assembly Member Seawright is co-sponsoring Assembly Member Glick's bill, A7798, to expand and improve speed safety cameras in New York City. This legislation would allow speed safety cameras in up to 750 school zones in New York City. It would also expand the radius to ½ mile from a school within which such a camera can operate and would allow the cameras to operate from 6 AM to 10 PM on all days. It will prohibit cameras within 300 feet of a highway exit ramp and will require signage within 300 feet of a school zone to alert drivers.

The New York City Department of Transportation is limited under state law and is currently only permitted to operate cameras in 140 school zones, on a ¼-mile stretch, and only on school days an hour before and after school hours. This leaves more than 93% of New York City schools unprotected, and 1 million students at risk.

“I commend my colleague Assembly Member Deborah Glick, Senator Jose Peralta, Transportation Alternatives and advocates for continuing the fight for the safety of our children with the Speed Safety Camera Act. According to Transportation Alternatives, speeding kills more New Yorkers than drunk driving and cell phone use combined. The numbers don't lie — in the 150 school zones where cameras have been installed, they have been impactful, decreasing speeding violations. I am proud to support legislation to keep our children out of harm's way in every neighborhood across our city. It is our duty to take the necessary steps to prevent tragedy with available technology by expanding, extending, and improving the speed safety program,” said **Assembly Member Rebecca Seawright**.

Speaking Out in Support of MWBE - Minority and Women Owned Business Enterprises



On Tuesday, June 6, Assembly Member Seawright was proud to stand with her Assembly and Senate colleagues as they continue to advocate and champion Minority and Women Business Enterprise issues. At the press conference, she commended Assembly Member Rodneyese Bichotte, chair of the subcommittee on MWBE, for her hard work, dedication, and commitment in addition to Senator Sanders for leading the cause in the Senate as their MWBE Task Force Chair.

"There are several driving goals as we craft legislation to promote Minority and Women Business Enterprises. We must level the playing field, eliminate disparities and create economic opportunity", **Assembly Member Rebecca A. Seawright said.** "Once we achieve these goals, we will see the continued growth and increased economic vitality of our MWBE community."

New York State Animal Advocacy Day



At the 7th Annual Animal Advocacy Day on June 6, Assembly Member Seawright joined fellow animal lovers to call for passage of “Kirby & Quigley’s Law” and other bills to protect pets and people.

Several bi-partisan public safety measures will be on the agenda including pushing the state Assembly to bring to the Floor for a debate and vote on “Kirby & Quigley’s Law” (S.1680/A.3038), which would make it a Buster’s Law felony punishable with 2 years in jail and a \$5,000 fine for harming a companion animal during the commission of another felony. “Kirby & Quigley’s Law” was named for two Montgomery County dogs that were shot and killed during a burglary last winter that is still an unsolved case. The State Senate voted across party lines to pass “Kirby & Quigley’s Law” five times, most recently in January by a 58-2 vote. It was referred from the Assembly Agriculture Committee and is currently in the Codes Committee. The bill has 81 sponsors in the Assembly, **including Seawright**, and 76 votes are needed to pass the bill on the Floor of the Assembly.

Assembly Member Seawright is a strong advocate for animals. [She fought tirelessly to save a coyote pup near Laguardia Airport](#) when authorities had been attempting to capture and euthanize the animal. Seawright partnered with animal advocates to provide transportation and a safe habitat for the coyote without burdening the taxpayers of New York.

"Animals do not have a voice, and it is up to us to identify ways to deal with coexisting in nature," **Seawright said.**

Recently, [Assembly Member Seawright called on the Department of Environmental Conservation](#) to investigate the cause of 41 whales washing up on the beaches and shores around New York City.

Seawright Votes for Two Bills that Give a Voice to and Protect Child Victims

Childhood Victims Act

On Wednesday, June 7, 2017, the Assembly passed legislation to ensure that victims of childhood sexual abuse have the opportunity to bring charges against their abusers in a court of law (A.5885-A). The Child Victims Act extends the civil and the criminal statute of limitations and also creates a one-year “window” in which past victims will be able to seek justice in court.

“Victims of childhood sexual abuse carry the trauma and pain with them for the rest of their lives,” **Assembly Member Seawright said.** “That’s why we must do all we can to empower victims, allow them more time to seek justice and help them move on with their lives. Childhood sexual abuse can leave lifelong scars. The time for talk is over. The time to pass this law is now.”

The Assembly bill would amend the criminal procedure law by adding five additional years for criminal charges to be brought – starting the clock at age 23, rather than at age 18 – as well as pushing back the statute of limitations to permit civil actions to be brought up until the victim’s 50th birthday. The measure also creates a one-year window for past sexual abuse victims to commence a civil action. Most importantly, this one-year window would permit courts to consider claims by victims which were previously dismissed or were not brought at all due to the limitations previously contained in the law.

Ending Harmful Child Marriages

Assembly Member Seawright helped pass legislation to outlaw child marriages in New York State by raising the minimum age for

marriage to 18 – or 17 with judicial consent (A.5524-B).

“Children shouldn’t be married, and the fact that they can be is both confounding and disturbing,” **Seawright said.** “The current law is archaic and it’s not in sync with other age restrictions such as for sexual consent, tattoos, smoking, voting, or military service. It’s time to put the needs of our children first and protect them from potentially unhealthy and often dangerous relationships that rob them of their innocence and their future.”

The Assembly’s legislation takes critical steps by abolishing any possibility of marriage for 14-, 15- and 16-year-olds. It would require court approval, pursuant to specified guidelines, under which a judge must consider specific factors, such as the existence of any undue power imbalance and the existence of domestic violence, prior to permitting a 17-year-old to marry.

Legislative Women's Caucus Dinner



On Wednesday, June 7th, at Legislative Women's Caucus Dinner, Assembly Member Seawright had the opportunity to reflect on the historically high number of women in the Legislature and celebrate the 100th anniversary of the Women’s Suffrage in New York State. They also congratulated their newly elected Executive Committee and Board members.

Window safety tips:

- Any window within 18 feet of ground level, a building projection, or a fire escape is considered to be an accessible opening that should be secured.
- If you live or work in a basement apartment, the windows may be secured with safety gates (or grilles) that contain a safety latch to allow for emergency exits.
- Do not assume that the basement windows are too small for entry. They are, in fact, one of the most popular points of entry for a burglar.
- The best and safest way to secure your fire escape or any first floor window is with a New York Fire Department-approved gate. This gate is commonly known as the "ferry" or "safety gate" and is operated by a latch (not a padlock or combination lock).
