#### Dear Constituent,

As a new legislative session starts in Albany, we have many opportunities before us. The Governor will be introducing his budget with his proposed initiatives. Unfortunately, leadership in Albany has been implicated in a number of unethical practices which make all of us look bad. One of the most important issues when we return to Albany is to address the underlying causes of these behaviors and put stronger measures in place to prevent future abuses of power which impact our entire state.

At the same time, I would like to hear from you about your ideas for important issues you feel we should be focusing on this year. Please join me at Town Meetings around the district and/or respond to the questionnaire on the back of this newsletter.

Once again, we will take a look at ways to fund education to take the burden off of the property taxpayers. We made some traction towards a circuit-breaker style of help with legislation passed in last year's state budget and were able to offer a number of tax give-backs. I will be working to make that even more helpful this year so that those who pay a disproportionate amount of their income to property taxes can get additional support.

This will also be a significant year in education as the chancellor has announced she will not seek another term, so our Regents, including our newly selected Regent Judith Johnson representing schools in my assembly district, will have the opportunity to choose a leader they believe will embrace their ideals, regarding testing, standards, evaluations, and other significant topics in education that impact our children and their future.

In October, I hosted a well-attended and robust panel discussion on Death with Dignity with pro and con speakers offering differing positions. I have included a review from the participants at the forum, and I hope that you will share with me in the questionnaire on the back your feelings on this controversial subject.

I continue to push back against the siting of Spectra Energy's high-pressure AIM gas pipeline near Indian Point. In November, I visited the Westchester County Executive to deliver a letter urging him to rescind the license he granted to Spectra to clearcut over 1,000 trees at Blue Mountain Reservation for this project without having asked for alienation of parkland legislation from New York State.

As you know, I count on your responses to my questionnaires to guide my actions. Please share your opinions and ideas with me so I can continue to have a clear understanding of what you believe is important and we can make progress together.

# Women's Equality

This year we voted on new laws to help women and families in New York State including protecting victims of sexual harassment, such as bill A. 5360, of which I was the prime sponsor in the Assembly. The following are the eight new laws signed by the Governor:



# **Achieving Pay Equity**

(S.1/A.6075) This bill strengthens New York's laws to further restrain employers from paying women less than men performing the same tasks. This bill will close the loophole that allows employers to prohibit employees from discussing their salaries under suspicion of being suspended or terminated. Now employees can freely discuss wages with each other, and the amount of damages employers face when violating the law is increased.

## **Protecting Victims of Sexual Harassment**

(S.2/A.5360) This bill protects employees from sexual harassment within the workplace regardless of employer's size. Currently businesses with fewer than four employees are not considered employers, barring employees from filing sexual harassment complaints to the Division of Human Rights. This bill would cover all businesses in New York and allow employees to file sexual harassment complaints when necessary.

#### **Removing Barriers to Remedying Discrimination**

(S.3/A.7189) This bill allows plaintiffs to recover attorney fees after a successful trial in employment or credit discrimination cases based on gender. This would allow victims the opportunity to maintain their rights and be made whole in cases where the plaintiff is successful. Currently in New York, state law prohibits plaintiffs from recovering attorney fees at trial for employment cases due to high trial costs.

#### **Ending Family Status Discrimination**

(S.4/A.7317) This bill prohibits employment discrimination

based on familial status. New York state law only prohibits discrimination based on familial status in areas of housing and credit. This often stereotypes employees that are parents or guardians of children under the age of eighteen. Women are most affected by stereotypical views of parents in the work place and are less likely to be recommended for hire or promotion. This new law bars employment agencies, licensing agencies, or labor organizations from discriminating against workers based on familial status.

# Protecting Victims of Domestic Violence from Housing Discrimination

(S.5/A.6354-B) This bill bans landlords from discriminating against victims of domestic violence. Currently New York state law states an individual could be denied housing based on his or her status as a victim of domestic violence. The new bill would protect victims of domestic violence from discrimination when attempting to rent or lease housing, as well as provide them with affirmative defense in eviction proceedings and a private right of action.

# Protecting Victims of Domestic Violence by Strengthening Order of Protection Laws

(S.6/A.6262) This bill creates a pilot program that allows domestic violence victims to seek temporary orders of protection through electronic means rather than having to appear in person. Currently, domestic violence victims can face vicious hardships when securing protection from their abusers.

## Strengthening Human Trafficking Laws

(S.7/A.506) This bill strengthens currents laws in New York State against human trafficking. It eliminates the constraint that coercion be proven in a sex trafficking prosecution when victims are minors, increases penalties for the crime and creates affirmative defense in prostitution prosecutions if the defendant was a trafficking victim.

## **Protecting Women from Pregnancy Discrimination**

(S.8/A.4272) This bill requires employers to provide reasonable accommodation for pregnant employees. Due to certain medical conditions some pregnancies may require that accommodations be made in the workplace. Current protections for pregnant women are unclear and often misinterpreted. A reasonable accommodation analysis must be conducted for pregnant employees.

# Death with Dignity Forum Update

As you know, on October 14th, I sponsored a Death with Dignity Forum - a pro and con discussion to consider New York State's approach to physician assisted suicide. We had over 125 in attendance and sought opinions from the attendees as to how they felt coming into the forum, how they felt after listening to the panelists and if they changed their opinion on this very sensitive issue.

Of those that responded, 55.6% came to the forum supporting physician assisted suicide, 33.3% opposed, and 9.5% had no opinion. After the panel discussion 74.6% said they learned new information about physician assisted suicide that they did not know before. When asked if any of this new information changed their opinion on physician assisted suicide, 14.3% said yes and 74.6% said no with 4.8% not sure. Some attendees did not answer every question.
