Desal Update: Water, Water Everywhere

Amy Vickers, a renowned water conservation and efficiency expert retained by the [Rockland Water Task Force](#) found that there was never a valid basis for United Water's proposed desalination plant, and that repairing a leaky system and boosting customer conservation could add millions of gallons a day to our local water supply. Fighting to Close Indian Point

I joined with those who live within 50 miles of the Indian Point Nuclear Power Plant, including elected officials and signed on to a letter to the Nuclear Regulatory Commission requesting that public hearings on relicensing the aging plant take place in White Plains, not Washington, D.C., to allow for community participation on this critical issue.

Seeking New Operator to Reopen Tallman Pool for Summer 2016



[The Palisades Interstate Park Commission](#) is hoping to identify a competent operator to renovate and operate the Pool at Tallman Park for the 2016 season. After six dormant seasons, the PIPC is releasing a new [Request for Proposals](#) in search of a new operator under a public-private partnership. The spectacular complex includes ample parking, one large adult and one separate kiddie pool, all with a picturesque view of the Hudson River that is unrivaled.

Pay Fast-Food Workers \$15 an Hour

I applaud the [NYS Wage Board's recommendation to raise the minimum wage](#) for the working poor who are struggling to provide for their families, many of whom are single parents. However, *no one* who works full time should have to live in poverty. That's why I co-sponsored and the Assembly passed legislation ([A.7257](#)) that would have raised the minimum wage for every worker.
