As we begin the 2014 Legislative session in Albany, I look forward to continuing the momentum we have established by moving New York forward with passing on-time budgets for the past three consecutive years, by providing middle class families tax relief and by bringing economic development and jobs back to Central New York.

I am pleased to announce that once again in 2013, I was ranked as the Assembly member who passed the most bills signed into law. I also held that distinction in 2012. I believe that these accomplishments are due to an ability to foster bi-partisan cooperation and to compromise, when necessary, to get this done for the benefit of my constituents. After all, this is what government was meant to do!

In addition to my legislative duties, one of the most important roles I have as your Assemblyman is being a voting member of the Governor's Regional Economic Development Council representing Central New York, which is comprised of Cayuga, Cortland, Madison, Oswego and Onondaga Counties. Over the last three years, Central New York has been awarded some of the highest grant totals of any of the Councils. In the 1st Round, the award was \$103.7 million (74 projects); the 2nd Round brought us \$93.8 million (73 projects); and in the 3rd Round, CNY has just been awarded \$66.9 million (79 projects).

All of the 2013 projects listed here benefit the people of Central New York. I am eager to work together with the Governor and my legislative colleagues to provide the State funding necessary to support additional projects which benefit Central New York.

A ssemblyman Magnarelli joined Governor Andrew Cuomo and the developers of the Syracuse Inner Harbor to announce the agreement to build a new Starwood Hotel and Resort. It will include a 130- room Starwood-brand hotel as the first part of the larger, 350-million dollar mixed-use waterfront development project. COR Development of Fayetteville is overseeing the entire harbor project, and was awarded 4.5 million dollars for site remediation and infrastructure development under the state's regional economic development council initiative.
