THE ANTI-GUN LOBBY ON APRIL 27th!

Organizations that want to restrict your second amendment right are gathering in Albany on 4/27. Be sure to contact your local Assembly representative to voice your concerns regarding increased regulation at 518-455-4100 or online at www.assembly.state.ny.us. Bills supported by the anti-gun lobby include:

- Requiring re-licensing and re-certification of firearms permits after 5 years (A. 801-A)
- Mandating microstamping capabilities for all semiautomatic pistols (A.6468-B)
- Creating and imposing restrictive commercial practices and stringent reporting on gun sellers, requiring liability insurance of at least \$1,000,000 and restricting premises of sales (A.1093)

Gov. Paterson Closing State Parks

Governor Paterson announced in February his plan to close 55 parks and historic sites, reduce services at an additional 24 facilities, and increase fees at state parks. Under the proposed closures, park officials said the grass would not be mowed, trails would not be groomed and roads would not be plowed. This would mark the first time in New York history that a state park was closed, ironically following a year where parks reached record attendance levels, as more New Yorkers have come to rely on these low-cost recreation facilities during the current economic crisis. The truth of the matter is New York cannot afford to close its parks. For every \$1 the state invests in parks, \$5 in economic activity is generated for the state.
