Creating Jobs


- Voted for legislation to support the electric plant repowering project like NRG in Dunkirk.
- Authorized \$150 million for the Regional Economic Development Councils.
- Implemented the Market-NY program to promote regional tourism and New York products.
- Supported funding to fight invasive species to help maintain Chautauqua Lake and thousands of local jobs.
- Enacted unemployment insurance reforms.

Improving Education


- Increased school funding for Chautauqua County schools by \$9.4 million, an increase of 5.3 percent.
- Provided \$55 million in new funding to continue improvements to the SUNY System.
- Increased support for JCC students to \$2,422 per student, up by \$150 per student.
- Supported public libraries with a \$4 million increase in funding.



Goodell encourages JBC students to exceed expectations.

Supporting Families

- Provided a record amount of funding for STAR property tax relief.
- Restored funding for EPIC co-payment assistance for seniors.
- Supported the restoration of funding to care for people with developmental disabilities.
- Voted for increased funding for child care centers and other child assistance programs.

Aiding Local Governments


- Dedicated over \$800 million for local roads for the next two years, an increase of \$75 million this year.
- Supported a moratorium on unfunded mandates from Albany that are raising property taxes.
- Cut the local growth of Medicaid, saving Chautauqua County taxpayers over \$810,000 over the last two years.



Additional highway aid will improve local roads and keep taxes lower.

Growing Agriculture

- Provided \$21.1 million for local agriculture assistance.
- Increased support for the Wine & Grape Foundation, a staple of Chautauqua County's agriculture industry.
- Supported an increase in funding for NYS apple growers and for Farm Net.
- Voted to reduce utility costs for our farmers, small-business owners, and all others.



Agriculture has been, and continues to be, central to life in Chautauqua County.
