**Greetings –**

I hope that those of you celebrating had a Happy Easter and that you enjoy a happy and healthy end to the Passover holiday. As you're probably aware, the Legislature and the Governor passed a \$168.3 billion budget last week for the upcoming fiscal year. **Leading the Effort to Permanently Ban Fracking in the Delaware River Basin:**

I, along with State Senator Liz Krueger and NYC Council Speaker Corey Johnson, sent a letter to the commissioners of the Delaware River Basin Commission, urging them to implement a complete and permanent ban on natural gas development and hydraulic fracturing (fracking) and all related activities within the basin. The Delaware River runs through four states - New York, Pennsylvania, New Jersey, and Delaware - and provides drinking water for more than 15 million people, including New York City.

The Delaware River Basin Commission is a federal-interstate agency formed in 1961 to manage the resources of the Delaware River watershed. The members of the Commission include the Governors of Pennsylvania, New York, New Jersey, and Delaware, and the federal government. Since a moratorium was enacted in 2010, the DRBC has had a de facto prohibition in place on all natural gas extraction projects in the basin, as well as associated activities including wastewater discharge and water withdrawals. However, new regulations recently proposed by the Commission would allow for some fracking wastewater treatment, storage, and disposal in the watershed, as well as the withdrawal of water to be used for fracking operations elsewhere.

Thirty-Seven other elected officials from the New York City area signed on to our letter calling for the Commissioners to revise the proposed draft regulations and enact this ban now. [You can view the complete letter on my website here.](#)

**Important Traffic Safety Meeting next Monday:**

On Monday April 9<sup>th</sup>, I am hosting a traffic safety meeting with Councilmember Brad Lander to discuss and hear your views on potential safety measures that should be taken at the Church Avenue and Ocean Parkway intersection in Kensington. [On February 27th, there was a tragic traffic crash that claimed the life of a pedestrian crossing Ocean Parkway at Church Avenue.](#) This intersection has seen tragedy take place before and having grown up just a few blocks away, I know how critical it is that city and state agencies investigate all possible solutions to make the intersection as safe as it can possibly be. Representatives from both the New York State and New York City Department of Transportation as well as the NYPD will be there to talk about the intersection, take your ideas, and discuss measures that they can take to prevent tragedies like this from happening in the future.
