


THIS MONTH IN ALBANY



A. Philip Randolph Senior Center Renovations

The A. Philip Randolph Senior Center will temporarily relocate for renovations and a redesign of its current space beginning in the spring of 2019. The Senior Center will remain on the main floor of the building, but move east, towards Lenox Avenue, into the adjacent smaller space for approximately two years during the renovation process. The ARC XVI organization is working with City Meals on Wheels to find two other vendors to provide catered meals to seniors while operating in the temporary space. The renovation of the current space is intended to modernize it and make it more accessible to visitors in order to better serve the community.

June Listening Tour at Esplanade Gardens and the Polo Grounds Recap

On June 22. 2018 from 7pm to 9pm. Assemblymember Taylor held a listening tour at Esplanade Gardens. Also in attendance were representatives from MTA, Access-A-Ride, FDNY, the Department of the Aging, Manhattan District Attorney's Office and NYPD 32nd Precinct. On June 23, 2018 from 10am to 12pm, Assemblyman Taylor



held his Polo Grounds Listening Tour. The agencies present included, Polo Grounds Management, Office of Intergovernmental Relations from the New York City Housing Authority (NYCHA), the Office of the Special Narcotics Prosecutor, the Department of Sanitation, the NYC Parks Department and Police Service Area (PSA) 6. Constituents were able to voice concerns and ask questions and the Assemblymember and panel members were able to respond and address constituents' comments and issues.

Hearing for 145th Street 3-Line Station Closing



The Assemblymember held a public hearing to address the 145th Street 3-Line train station closing at nearby A. Philip Randolph Senior Center so that the

hearing was more easily accessible by community members. The station closed on July 23, 2018 and will remain closed until November 2018 for station renovations and repairs under the MTA's Enhanced Station Initiative.

Fighting Against the HDFC Crisis

Assemblymember Al Taylor recognizes that there is a crisis in the Housing Development Fund Company cooperative buildings (HDFCs). The crisis developed over a number of years and is growing exponentially

in the 71st Assembly District. In response to the crisis, Assemblymember Taylor decided to create a four-part forum series for constituents to voice concerns and to work with experts to develop solutions via legislation, litigation or negotiation. The first forum was already held on August 27, 2018 in the Myrna L. Daniels Auditorium at Columbia Presbyterian Hospital to address concerns about HDFC foreclosure. Panelists included Edwin Vega from Legal Aid Society, Glory Kerstein from the HDFC Coalition, Shimlee Lambert, Treasurer to 936-938 Cliffcrest HDFC, Yetta Kurland, Attorney for 936-938 Cliffcrest HDFC. Special



guests included Manhattan Borough President Gale A. Brewer, Senator Brian Benjamin, Remysell Salas from the Office of New York City Mayor Bill de Blasio, and Shatic Mitchell from Community Board 10. Assemblymember Al Taylor and Darlene Bruce, Esq. moderated the event. WeAct and Neighborhood Housing Services also were present to table and act as resources for HDFC residents. Three more meetings are scheduled at Columbia Presbyterian Hospital to discuss regulatory agreements (September 24, 2018), predatory lending (October 15, 2018), and the HDFC environment and quality of life (November 5, 2018). The feedback from these forums will be taken back to the appropriate committees to help produce legislative solutions. As the Chair of the New York State Assembly Subcommittee on Regulated Mortgage Lenders, Assemblymember Taylor wants to hear from constituents to produce positive results and pledges to fight to stabilize buildings, empower the community and bring an end to the crisis facing HDFCs.
