Assemblymember Rodneyse Bichotte Chair, Subcommittee on Oversight of Minority and Women-Owned Business Enterprises

#### Dear Friends,

As Chair of the Subcommittee on Oversight of Minority- and Women-Owned Business Enterprises, my goal is to have my ear to the ground and introduce responsive and meaningful legislation that will support and potentially transform the

Therefore, in this legislative session, I have committed myself to turning those conversations into action by introducing a comprehensive package of MWBE legislation. I look forward to continued dialogue.

The first piece of legislation that I introduced this year was A.8700, which will require any locality or municipality that receives money from the state, and those businesses with which they work to attach an MWBE goal to their projects. Including this bill, I have introduced a total of 13 pieces of legislation that I believe will benefit MWBEs and subcontractors, in addition to A.8044-A that increases discretionary purchase to \$200,000 in New York City, which was passed

The legislation falls mainly into five categories:

- increased opportunities for MWBEs by attaching MWBE participation goals such as those entities receiving real estate
- increased resources to expand the pool of certified MWBEs, such as appropriations for outreach, and a feasibility study
- increased transparency and accountability such as the public sharing of data on MWBEs, companies who have received
- state contracts and companies who have received waivers in regard to compliance with MWBE participation; • the way in which prime contractors and subcontractors will be paid and reported on in regard to MWBE contractual
- the lifting of barriers such as the \$3.5 million cap on net worth, which limits the capacity and growth of MWBEs. As always, should you have any questions about MWBEs, please contact my office at 718-940-0428. You can also go to

# **LEGISLATIVE CORNER**

#### Bichotte introduces 13 new bills this legislative year

#### A.8044-A

Passed the assembly. The purpose of the bill is to increase the city's MWBE discretionary spending of the small-purchase threshold from \$100,000 to \$200,000, allows MWBE status to be a factor in "best value" awards, establishes capacity building programs for the benefit of state or local MWBE-certified firms doing business in New York City and permits pre-qualified lists for purchase contracts in addition to public works contracts.

#### A.8700

Helps widen opportunities for minorityand women-owned business enterprises throughout the State of New York by attaching a MWBE participation goal to any grant received by a locality or municipality, as well as those entities that conduct business with said localities and municipalities.

#### A.9074-A

Requires a minority- and women-owned business enterprise participation goal requirement in order to receive exemption of new multiple dwellings from local taxation, such as 421-a.

#### A.9122

Studies which state agencies and industries would benefit most from having a capacitybuilding/mentorship program, and the duration and cost of such a program.

#### A.9700

Amends the sole source procurement process so that it will include the solicitation of MWBEs.

#### A.9707

Helps enable under-represented MWBEs to be exposed to government contracting opportunities and resources.

#### A.9708

Allows the public to see which contracts have received waivers in relation to compliance with MWBE participation.

#### A.9710

Requires contractors to report their contractual relationship throughout the life of the project with MWBEs.

#### A.9733

Allows the Division of Minority and Women's Business Development to issue an annual report which will summarize the different information required for their development, including breakdowns by race, gender, contract type, value of contract, and number of contractors, both prime and subcontractors.

#### A.9740

Helps streamline the payment process for both prime contractors and subcontractors.

#### A.9771

Publishes and announces agencies that have entered into a contract with the state.

#### A.9772

Requires real estate developers that are able to claim certain tax credits, abatements and exemptions to attach an MWBE goal to their project.

#### A.9774

Eliminates the requirement that MWBE owners have a personal net worth of less than \$3,500,000 in order to obtain certification as a qualifying MWBE.

#### A.9775

Requires the NYS Comptroller to report on minority- and women-owned business development and contract spending.

### **OPPORTUNITIES**

#### LaGuardia Redevelopment Program

The program will include the demolition of the existing Central Terminal Building and associated infrastructure and the construction of a new 1.3 million square foot, 35 gate terminal building; a new aeronautical ramp; frontage roads that will serve the new terminal; a new central heating and refrigeration plant; and other utilities and site improvements. This program is run by the Port Authority of New York and New Jersey (PANYNJ).
