Legislative Victories in 2023

I was proud to be the primary sponsor of the following bills that passed the Assembly since my last newsletter:

- A01191, Epstein Requires the Department of Environmental Conservation, in coordination with NYSERDA, to take a thorough accounting of funds allocated and spent toward meeting the state's climate goals in an annual report
- A01122, Epstein Requires commercial parking garages that receive state funds to install charging stations to pay for charging without an additional cost to park while charging
- A05815, Epstein Mandates an annual report on the participation of individuals with disabilities in New York state contracts. This data will provide greater transparency and help create equitable representation for all New Yorkers in our state contracts
- A04504, Epstein Adds a Transit-Dependent Individual to the MTA Board to ensure that the MTA leadership prioritizes making our transit system accessible, equitable, and efficient for all New Yorkers



- A00458, Epstein Provides deceased tenant's legal representatives the option to terminate a tenant's lease upon notice to the landlord
- A02176, Epstein Mandates a frequent comprehensive report on unaccompanied minors and separated children in the foster care system
- A6672, Epstein Makes it easier for students to recover student debt by allowing the place of trial to be the residence of the defendant

Local Impact

This past year my office has:

- Distributed over 500 bags of donated clothing to asylum seekers in our district
- Allocated millions of capital and operating dollars to community nonprofits, local schools, and public housing developments
- Resolved over 600 constituent cases with issues ranging from housing to healthcare
- Held dozens of community events and Hang with Harveys to talk to community residents and hear their concerns
- Toured numerous nonprofits in our community and learned about their services
- Attended dozens of community meetings around affordable housing, public safety, community activities, etc.

Harvey Helps

This year, we had a mother reach out to our office because she was unable to afford childcare, which meant she could not work to provide for her family. This situation is all too common. My office sprung into action by contacting the NYC Human Resources Administration on her behalf to get her a childcare voucher. This mother is now able to work full-time and therefore provide for her family. We are committed to empowering constituents to break the cycle of poverty.
