Assembly Member Seawright Supports Initiatives Leading to a Major Drop in Gun Violence Across New York

Assembly Member Rebecca Seawright applauds the 14% decrease in shooting incidents with injury in communities participating in the Gun Involved Violence Elimination (GIVE) initiative during the first seven months of 2025, announced by the Office of Governor Hochul. This decline is attributed to state investments and strong collaboration between local law enforcement and community organizations.

Shooting deaths also dropped by 21% compared to the same period in 2024, with notable reductions by nearly 20% in New York City.

Recent legislation cosponsored and strongly supported by Assembly Member Seawright has strengthened New York's approach to preventing gun violence, including the codification of the Office of Gun Violence Prevention, safe firearm storage requirements, and enhanced measures under the state's Red Flag Law. These efforts have been instrumental in reducing shootings and keeping communities safer.

Less Scrolling, More Learning.

Starting this school year, all K-12 public schools across New York State are going distraction-free! Governor Hochul's new policy makes New York the largest state in the nation with a bell-to-bell restriction on cell phone use, and it's going to help our kids focus on the most important parts of school: getting a great education and making in-person connections with their peers. Schools have spent months

More Learning, Less Scrolling: Creating Distraction-Free Schools

Recognizing the necessity of ensuring safe and productive learning environments for students and educators, Governor Hochul advanced legislation to create a statewide standard for distraction-free school environments and secured its passage in the FY2026 budget. The enacted legislation aims to create safer, more productive learning environments by minimizing distractions from smartphones and similar technology in K-12 schools statewide.

Key Provisions

As the most populous state with a statewide, bell-to-bell restriction, Governor Hochul's cellphone policy creates a model standard including:

- No unsanctioned use of smartphones and other internet-enabled personal devices on school grounds in K-12 schools for the entire school day (from "bell to bell"), including classroom time and other settings like lunch and study hall periods.
- Allowing schools to develop their own plans for storing internet-enabled devices during the daygiving administrators and teachers the flexibility to do what works best for their buildings and students.
- Securing \$13.5 million in funding to be made available for schools to aid in purchasing storage solutions to help them go distraction-free.
- · Requiring schools to give parents a way to contact their children during the day when necessary.
- · Requiring teachers, parents and students to be consulted in developing the local policy.
- Requiring schools to annually publish a report detailing the enforcement of the policy they adopted, helping to prevent inequitable discipline.

Exemptions, Discipline, and Applicability

Exceptions to the restrictions include:

- · Use authorized by school staff for educational purposes
- Emergency situations or healthcare management
- Translation needs
- · As required for individualized education (IEP or 504 plans)
- Special caregiver responsibilities (case-by-case basis)

Students cannot be suspended solely for policy violations. Enforcement must be fair; annual demographic data reporting is required to spot and address any disparities.

This legislation applies to school districts, charter schools, and boards of cooperative services (BOCES).

MTA Reduced-Fare Program: Half-fare benefits are moving to OMNY. New cards should have arrived; continue using MetroCards meanwhile. Check updates at MTA Reduced-Fare OMNY info.

MTA Mobile Sales: Services include reduced-fare applications, OMNY sign-ups, card balance transfers, and lost card reports. Schedule at mta.info/fares/mobile-sales.


