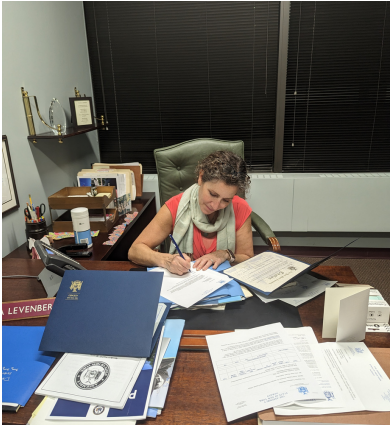

My office fields lots of emails and phone calls every day, including hundreds of comments on pending legislation. If you have sent a comment, please know that my staff and I do review every message and keep track of how many comments we receive in support or opposition to legislation under consideration, and plan to respond when there are updates on the progress of a law.

If you have recently reached out to us about state roads, please know that we are keeping track of those complaints as well. I am sending a separate communication about state roads in our district, which will also be posted on my website and social media pages. Stay tuned for more on that very soon.

We have also received some inquiries regarding state and federal rebate programs and other assistance for switching from gas-powered to electric appliances. If you would like to learn about rebate programs and other support for transitioning to renewable home energy sources, Sustainable Westchester's EnergySmart Homes program can help. I have also signed on to co-sponsor multiple pieces of legislation that align with my mission of building healthy communities - environmentally, economically, physically and mentally healthy, all through the lens of equity. I was particularly proud to co-sponsor the second passage of the Equality Amendment, which will strengthen New York State's commitment to the right to privacy and equal protection under the law.
