The Harm Caused by Trump's H.R. 1

Healthcare at risk

- More than 2 million New Yorkers could lose health insurance
- Hospitals could face reduced services and possible closures, resulting in diminished health services for all
- Thousands of workers in healthcare could lose their jobs, causing grave harm to New Yorkers and our health care system, while damaging our economy

Food assistance in jeopardy

- 3 million New Yorkers rely on SNAP (food stamps) - over 300,000 families could lose benefits

Climate crisis denial

- Promotes fossil fuels and eliminates incentives for renewable energy programs and projects, including:
 - Residential solar conversions
 - Tax credits for electric vehicles
 - Tax credits and funding for wind and solar generation projects

Shredding due process and criminalizing immigrants

- Provides \$75 billion more for ICE detentions and deportations of immigrants with no regard for due process

What New York State Can Do

What New York State Can Do to Protect Programs and Services

- Identify additional broad-based revenue sources
- Strategically draw on New York State's budget reserves to fill short-term budget gaps
- Prioritize vulnerable people over corporations and the wealthy

What New York State Can Do to Protect Residents from ICE's Unconstitutional Conduct

- Pass the New York For All Act (A.3506/S.2235), which would prohibit New York state and local government agencies, including police and sheriffs, from cooperating with ICE, disclosing sensitive information, and diverting personnel or other resources to further federal immigration enforcement
- Pass the Dignity Not Detention Act (A.4181/S.316), which would bar local jails from renting out cell space to U.S. Immigration and Customs Enforcement (ICE)
- Pass the Access to Representation Act (A.270/S.141), which would establish a universal right to counsel for low-income New Yorkers who are subject to removal proceedings under federal immigration law
