In New York State and the Capital Region, we are finally emerging from the worst of the global COVID-19 pandemic, and beginning to navigate and understand what has become our 'new normal.' Across the nation, a wave of demonstrations and protests, spurred by the killing of George Floyd presents us with an opportunity to seize what is a historic moment of change to root out systemic inequalities faced by people of color in this country for too long. Only halfway through 2020 – this year is already proving to be a watershed moment and year in American history.

The New York State Legislature continues its work of responding to the COVID-19 pandemic through passage of rent relief for tenants, and public hearings to assess the impact of COVID-19 on the state economy, health care, long-term residential care, and more. Additionally, we've seized the moment of change and enacted a

series of historic policing reforms in New York State, including the repeal of section 50-a. I've introduced two major pieces of legislation to help New York's economy recover by creating a New Deal-style jobs program similar to the original Works Progress Administration (WPA), and through comprehensively expanding and transforming New York's Earned Income Tax Credit (EITC) to make more households eligible.

I continue to be inspired by our community's resilience and unity throughout what has been a challenging year. I am honored to represent each of you in the New York State Assembly, and I am working to ensure the Capital Region and our local economy emerges from this crisis stronger and more vibrant than ever.

New York Tough & Capital Region Strong – The Path Forward

New York State's rapid response to the arrival of COVID-19 beginning in early March has helped ensure that numbers have dramatically fallen. While we remain vigilant in continuing to wear masks and socially distance, focus now falls to the state's recovery. In May, the Legislature authorized \$100 million in rental assistance as a first step towards providing rent relief to New York tenants and renters hardest-hit by the COVID-19 pandemic. However, major sectors of the economy, will require a large commitment from the federal government to provide a financial lifeline to states like New York who've been hit the hardest by the economic slowdown.

As we continue to adjust our new normal accordingly, I've joined several colleagues to advocate for increased flexibility in certain reopening guidelines and other sectors of the economy where appropriate and necessary. Moreover, the preference given to big box stores in comparison to locally-owned small businesses will continue to be a focal point of my advocacy moving forward – small businesses and 'Main Streets' are the lifeblood of our communities.



Packing Meals for the 518: In early June, I joined the Catholic Charities of the Diocese of Albany in handing out prepared meals for our neighbors and broader Capital Region community.

Visitation of Nursing Homes and Assisted Living Facilities

Families have had to wait numerous months before seeing their loved ones in nursing homes and assisted living facilities. Joining my colleagues in the legislature, we urged the state to reconsider this policy and in early July, permitted facilities authorized limited visitation given that there have been no new cases for 28 days. Still, more needs to be done and flexibility is needed for residents and families.

Childcare

In June, I was proud to sign onto a joint letter among Upstate Assembly colleagues urging an increase to the limit of 10 children per classroom in childcare and summer camps, a critical program and service for countless working families in New York State. Guidance has since been revised to increase that number to 15. Child care affordability and accessibility continues to be one of the most critical issues in the state and a top priority of the Legislative Women's Caucus and I look forward to addressing this with my colleagues during the legislative session.

The Legislature's Recent Response to the COVID-19 Crisis

In May, the state legislature passed a package of bills aimed at dealing with some of the most immediate effects of the COVID-19 pandemic. This included measures to help keep New Yorkers in their homes through rental and mortgage assistance and to prohibit evictions for the duration of the crisis, authorize benefits for families of employees lost to COVID-19 on the frontline, improve mobile voter access, and expand New Yorkers' access to telemedicine and telehealth services (which have now become essential to our healthcare system).

Highlights of these bills include; legislation to ensure audio-only and video-only telehealth and telemedicine services will be eligible for reimbursement, legislation providing financial and budgetary flexibility to local governments as they continue to operate and provide essential services, and legislation enabling New Yorkers to apply for absentee ballots through an electronic application.

Reopening Malls

Many locally-owned small businesses in malls throughout New York State were adversely impacted by the decision to delay reopening originally slated for Phase 3 until early July. As major drivers of revenue and jobs in local and regional economies, hundreds of workers depend on these establishments for income, and I was proud to host my legislative colleagues in urging that malls be allowed to reopen safely and responsibly in a limited manner.



At Crossgates Mall to urge the state to reopen malls and businesses: On June 11th, I was joined by Assemblymember John McDonald, Albany County Legislator Dustin Reidy, Town of Guilderland Supervisor Peter Barber, and local business leaders from the Capital Region Chamber, Guilderland Chamber of Commerce, including representatives of Spa Mirbeau - Albany, Laced Up, and The Standard, to urge that the state reopen malls and businesses.

Ensuring Our Recovery Works for All New Yorkers New Proposals


Expanding NY’s Earned Income Tax Credit (EITC) (A.10775/S.8670)

In July, I introduced legislation to address income inequality with state Senator Anna Kaplan (A.10775 Fahy/S.8670 Kaplan) to expand New York’s Earned Income Tax Credit (EITC). At both the federal and state levels, EITCs have been proven to be one of the most effective economic and social equalizers, lifting millions of Americans and their families out of poverty every year. In the United States, 39% of working people earning less than \$40,000 either lost their jobs or were furloughed due to COVID-19 pandemic in March of 2020 alone. Expanding New York State’s Earned Income Tax Credit (EITC) would significantly raise the maximum income thresholds to include hundreds of thousands of working NYers not previously eligible.

Struggling workers and families need cash now to afford necessities and pay bills. Low-income NYers have been hit the hardest by the #COVID19 pandemic. Expanding NY’s EITC eligibility would ensure that we’re supporting some of our most essential workers and injecting badly-needed dollars into our economy. The ‘bottom-up’ recovery is needed to combat the ever-growing wealth gap between the ultra-wealthy and middle/lower classes.

The Push for Jobs: A New Works Progress Administration Recovery Act (NY WPA) [A.10480 Fahy/S.8440 May]


I’ve introduced legislation alongside Senator Rachel May (D – Syracuse) to create a state-level New Deal-style public jobs and works program to create good-paying jobs fast and get New Yorkers back to work, described in an op-ed published by The Altamont Enterprise (‘The Case for a 21st-Century WPA – We Must Be Bold As Well As Practical’) and the Albany Business Review (‘It’s Time for a New Works Progress Administration’). Almost 2 million NY workers are out-of-work due to #COVID19, with many of those jobs potentially lost for good. We need a statewide, short-term #NewWPANow to unleash the potential of New York State’s workforce, restart and reinvigorate the economy. The United States economy is in disarray on a scale that our nation has not seen since the Great Depression. Let’s secure funds for a new WPA in the next federal stimulus package and focus on low-wage workers, families, and millennials as they are bearing the brunt of the economic fallout.



New Legislation Alert

Expanding New York State's Earned Income Tax Credit (EITC) A.10775




Makes the following households and individuals eligible for the first time:

- Young adults under age 25 who have no children
- Immigrants who do not have a social security number but pay taxes



Increases the phase-out start point to make more NYers eligible:

- \$8,790 to \$24,960 for childless adults and single parents
- \$14,680 to \$29,960 for joint filers



CREATES FLEXIBILITY FOR WORKING FAMILIES THROUGH AUTHORIZING ADVANCE PAYMENTS IN THE FORM OF INSTALLMENTS FOR THE FIRST TIME

Raises the value of NY'S EITC from 30 to 35% of the federal EITC in 2020, and to 40% of the federal EITC in 2021+, while doubling the phase-out rate from 7 to 15-percent for single or married households with 1 or fewer children.

• Almost **40% of workers** in American households making **less than \$40,000/year** have either been furloughed or laid off since March 2020, while the ultra-wealthy have become **\$585 billion richer** since then.

Black Lives Matter – Seizing the Moment of Change & Passing Historic Policing Reform

I was proud to join my colleagues in the Black, Puerto Rican, Hispanic, and Asian Legislative Caucus, Assembly, and State Senate to pass historic police reform legislation aimed at reforming and transforming policing in New York State. The below package of legislation passed by the Assembly is a critical first step in addressing the longstanding, systemic inequalities that adversely impact too many communities and people of color in New York State.

New Legislation to Improve Accountability of Police Misconduct (A.10630)

In an effort to hold law enforcement agencies and police departments more accountable to the public, I've introduced legislation with state Senator Robert Jackson (D – NYC) granting immunity to police officers and law enforcement employees who intervene in or report instances of police misconduct. Currently, officers who report or intervene in police misconduct or attempt to prevent violence or misuse of force face professional retaliation and in many cases, termination, stifling any voices seeking to do what is just.

We have more work to do in advancing justice through combatting persistent, rising income inequality, creating jobs and more, and I am anxious to continue work to address these challenges.

Making Juneteenth A State Holiday

Celebrated on June 19th of every year since 1865, this day commemorates the end of slavery in the United States over 150 years ago, when the last slaves in the rebelling states were freed by Union troops at the end of the Civil War. The Legislature passed and the Governor signed legislation to make it an official state holiday by 2021. While we know that inequalities in our state are pervasive and require real policy solutions, it is critical we better integrate the story and history of Black Americans into our nation's broader and collective historical narrative.


