## ■ Bills I Care About in 2026:

An overview of the bills I'm fighting for... crafted to meet rising community needs and deliver progress on housing, safety, and sustainability.

### ■ **A6316: Allowing Dying Declarations in Court**

This bill formally allows statements made by someone who believes they are about to die to be used as evidence in court. It clarifies an important legal standard, and it brings New York in line with long-standing legal practice used in many other states.

### ■ **A6443: Supporting Local Breweries with Expanded On-Site Sales**

This bill allows licensed breweries and farm breweries to sell merchandise beyond beer and operate additional small businesses on their premises. It boosts local entrepreneurship and supports New York's growing craft beverage industry. Put simply: this bill provides more flexibility for small producers.

### ■ **A7595: Right to Preventative Maintenance of Wheelchairs**

This bill directs the NYS Department of Health to establish a program ensuring people who rely on wheelchairs get preventive maintenance and repairs. Regular maintenance keeps people mobile, safe, and independent, and can prevent costly hospital visits from equipment failures. It's about dignity and reliable access to essential medical devices.

### ■ **A8850: Protecting Patients When Insurance Networks Change**

This bill ensures that if your doctor or specialist is suddenly dropped from your insurance network due to a dispute between the insurer and provider, you won't be left without options. It creates a new special enrollment period so consumers can switch to a plan that still covers their preferred provider. This protects continuity of care and prevents people from having to choose between paying out-of-pocket or losing access to trusted medical professionals. The bill responds to recent Capital Region disputes that left thousands of patients in limbo and provides a fair remedy for situations outside a consumer's control.

### ■ **A8920: Placing Restrictions on the Sale of Flare Guns**

This bill would prohibit the sale of flare guns to anyone under 21 and requires age verification with government issued-ID. The law balances safety concerns with reasonable exemptions for law enforcement, military, boating, and supervised programs. It establishes both civil and criminal penalties to ensure meaningful enforcement without over-penalizing first-time offenders.

### ■ **A9076: Combating the Federal Government - Standing up for our Rights**

We have to start thinking creatively to protect New Yorkers. I'm proud of this bill that I introduced with Senator Myrie, a fellow lawyer, that uses an important piece of federal law, Section 1983, to our advantage. This bill gives New Yorkers a clear way to take action in New York's state courts when a government official violates their federal constitutional rights. This bill allows people to seek meaningful remedies, including compensation for harm, punitive damages, court orders to stop unlawful behavior, and attorney's fees. Federal inaction has left many residents without a path to justice when their rights are violated, but this law fills that gap by allowing you to sue in state court.

At its core, this legislation is about standing up for everyday people, defending civil liberties, and making sure that government power is used constitutionally. With this legislation, New York is sending a clear message: your rights matter, and you have the power to fight to make sure they are enforceable.

### ■ **A9181: Statewide Student Attendance Dashboard**

This bill creates a publicly accessible, statewide dashboard tracking student attendance and absenteeism across all school districts. It provides timely, standardized data so parents, educators, and policymakers can see trends and take action. Chronic absenteeism has become a serious concern, and this tool will help identify schools and districts that need additional support. By increasing transparency, the dashboard strengthens accountability and helps guide interventions to improve student engagement and equity.



# ■ Assemblymember Gabriella A. Romero's 2025 Funding Recap:



While I love legislating and addressing constituent concerns, one of my most important responsibilities as a legislator is allocating discretionary funds. I'm proud of the programs we created and the projects we supported this year. Each commitment reflects

a real need in our district that came directly from you. Below, you'll find a breakdown of the Capital (physical projects and equipment) and Operating (programmatic) grants we awarded this year.

## Operating Funds:

United Tenants of Albany - \$20,000  
New Scotland Community Food Pantry - \$10,000  
Sweet Pilgrim Missionary Baptist Church Soup Kitchen - \$10,000  
Pride Center of the Capital Region - \$30,000

Family Promise of the Capital Region - \$10,000  
Underground Railroad Education Center - \$30,000  
Jewish Family Services - \$90,000  
City of Albany Holiday Market & Youth Empowerment Programming - \$80,000

I know that the process for obtaining state funds can be confusing, and sometimes even intentionally complicated. That's why I hosted an event with the Executive Chamber and leaders of the Statewide Financial System to guide nonprofits and anyone interested in grants through the process. Together, we cut through the red tape and pulled back the curtain on how to access these resources. I loved hosting this event for the community and look forward to doing it again next year.
