The United States Environmental Protection Agency (EPA) "Characterization of Municipal Solid Waste by Weight" reports indicate that the amount of discarded electronic waste, commonly referred to as E-waste, is rising. In 2011, 3.4 million tons of E-waste were generated, up from 1.9 million tons in 2000. E-waste, such as televisions and computers, typically includes harmful chemicals such as lead, cadmium, mercury and flame retardants. In 2010, the Legislature created a statewide electronic equipment reuse and recycling program to encourage recycling and prevent the disposal of E-waste in landfills. This hearing is intended to examine the effectiveness of the State's E-waste program including collection rates, administration, and manufacturer compliance.

Persons wishing to present pertinent testimony to the Committees at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to ten minutes' duration. In preparing the order of witnesses, the Committees will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible. Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committees would appreciate advance receipt of prepared statements.
