### **ORAL TESTIMONY WILL BE BY INVITATION ONLY**

Intercity passenger rail service, which is furnished by the National Railroad Passenger Corporation (Amtrak), provides intrastate, interstate, and international mobility for people travelling along rail corridors across New York State. Rail passenger service that is frequent, reliable, is in a state of good repair, and whose on-time performance reduces travel time is key to increasing its attractiveness and, thus, its use. Strengthening the attractiveness and competitiveness of intercity passenger rail service could help the State in meeting its environmental and economic goals, by consuming less energy, reducing congestion and vehicle emissions, supporting smart land use policies, and providing workers, tourists, and other travelers with a reliable mode of transportation.

This hearing will provide the Assembly Standing Committee on Transportation an opportunity to review and assess various aspects of intercity passenger rail service within New York State relating to rail infrastructure and operating issues that impact its reliability, frequency, on-time performance, and state of good repair. The Committee also is interested in obtaining testimony on the need for future rail investments to meet these goals, and the availability of federal funding for such investments.

Persons invited to present pertinent testimony to the Committee at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

In preparing the order of witnesses, the Committee will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committee would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to meet the needs of those who may have a disability, the Assembly, in accordance with its policy of non-discrimination on the basis of disability, as well as the 1990 Americans with Disabilities Act (ADA), has made its facilities and services available to all individuals with disabilities.
