NOTICE OF PUBLIC HEARING

SUBJECT: Cannabis Banking in New York State

<u>PURPOSE</u>: The purpose of the hearing is to examine how to establish a legal framework in

providing banking services to cannabis businesses in New York State

Recreational adult-use cannabis is now legal to cultivate, process, distribute and sell at retail to adults 21-years and older in New York State. However, cannabis is still labeled a controlled substance at the federal level, which results in restricted access to federally regulated banks and financial services. New York's adult-use cannabis businesses currently operate as cash-only businesses.

Operating a cash-only business raises challenges including security, payroll, access to loan-products, and recordkeeping. These challenges impact both the legal cannabis-related businesses and the banks seeking to provide services.

In 2014, the U.S. Department of Treasury issued guidance, Financial Crimes Enforcement Network (Fin CEN), related to how financial institutions can provide services to the legal cannabis industry sector that are consistent with other banking requirements. On March 1st, 2023, U.S. Attorney General Merrick Garland announced plans before the U.S. Senate to reinstate protections outlined in the 2013 "Cole Memorandum," which provided states with regulated cannabis industries a limited pathway to conduct business. The states of California and Colorado, who have legalized recreational cannabis, have used Fin Cen guidance to authorize state-chartered banks and credit unions to provide cannabis businesses with essential banking services. The committees seek to analyze challenges and barriers to providing banking services to legal adult-use cannabis businesses and examine pathways to allowing banking services to the burgeoning cannabis industry in New York.

Persons wishing to present pertinent testimony to the Committees at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to five minutes' duration. In preparing the order of witnesses, the Committees will attempt to accommodate individual requests to speak at times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committees would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

To further publicize these hearings, please inform interested parties and organizations of the Committees' interest in hearing testimony from all sources.
